

# PETITION INSTRUCTIONS

- Only registered voters in California may sign this Petition. (If someone is not yet registered, have them visit <https://registertovote.ca.gov>, to register prior to signing.)
- Use only Black or Blue ink & print neatly. **DO NOT TYPE!**
- Each person's Name, Address and Signature **MUST MATCH** their voter registration information. Questions? Visit <https://voterstatus.sos.ca.gov> to check voter status.
- Set printer to 100% & portrait. Do not "fit to page". Margins are specific **DO NOT PRINT SCREEN, YOU MUST DOWNLOAD & PRINT**
- **IMPORTANT:** YOU ARE "The Circulator." For the Petition to be valid, YOU MUST COMPLETE ALL of the "Circulator" fields before you turn it in or mail it in.
- Each Petition may contain signatures ONLY from a **SINGLE** County. Friends from another county? Start a new form for them. OK for you to be the Circulator.
- Any quantity of signatures is acceptable per petition.
- Return completed Petitions to the address at the bottom of this form — preferably no later than March 10, 2021!

Use a **SEPARATE** Petition for **EACH** County!

**DECLARATION OF PERSON CIRCULATING SECTION OF RECALL PETITION: (MUST BE IN CIRCULATOR'S OWN HANDWRITING)**

I, Print your name (You MUST be 18 or older...) solemnly swear (or affirm) all of the following: (1) That I am 18 years of age or older. (2) That my residence address, including street and number is Full street address, City, Zip where you live. NO PO BOX allowed... (If no street or number exists, a designation of my residence adequate to readily ascertain its location is Complete ONLY if you HAVE no street address!).

(3) That the signatures on this section of the petition were obtained between the dates of START / DATE (2020) and END / DATE (2020) that I circulated the petition and I witnessed the signatures on this section of the petition form being written; and that, to the best of my information and belief, each signature is the genuine signature of the person whose name it purports to be. (4) That I showed each signer a valid and unfalsified "Official Top Funders" sheet, as required by Elections Code Section 107.

I certify under penalty of perjury under the laws of the State of California that the foregoing is true and correct.
